## Environmental Hazards

### AGRICULTURAL USE REQUIREMENTS

Use this product in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. ### APPLICATION INSTRUCTIONS

Use Furadan LFR at a rate of 3 quarts per acre (7.2 fluid ounces per 1,000 feet of row). Make application from at planting up to a four inch rosette.

**For Planting Time Applications:** Band to the side or below the seed piece. Do not apply above the seedpiece.

**For Sprinkler Irrigated Fields:** Apply in sufficient carrier for thorough coverage. Apply as a 4 to 6 inch band over the plant row or shank in 4 inches deep on both sides of the plant. Irrigate as soon as possible after treatment.

**For Furrow (Gravity) Irrigated Fields:** Shank in 4 to 6 inches to the water side of the row and approximately 4 inches deep. Irrigate as soon as possible after treatment.

Furadan LFR may be mixed with liquid fertilizers or water. If liquid fertilizer is used, check physical compatibility before mixing large quantities.

### RESTRICTIONS

If Furadan LFR is used according to this label, do not make a foliar application of Furadan LFR.

Do not apply more than 3 lbs ai/acre of carbofuran (3 quarts of Furadan LFR) per season.

Do not apply more than 2 pints per acre per season in areas having greater than 90% sand and less than 1% organic matter where the water table (groundwater) is shallow (less than thirty feet).

Do not harvest within 75 days after application under this SLN label.

Furadan spray solution must have a pH of 7 or lower. The use of a buffering agent may be necessary.

Do not use this product through any type of irrigation system.

For waterfowl protection do not apply:—immediately before or during furrow irrigation—on fields in proximity of waterfowl nesting areas—on fields where waterfowl are known to repeatedly feed
