DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This labeling must be in the possession of the user at the time of application. Follow all applicable directions, restrictions, Worker Protection Standard requirements, and precautions on the EPA registered label.

GENERAL INFORMATION

DuPont™ VELPAR® DF Herbicide is recommended for the suppression of prickly lettuce and quackgrass and control of Canadian thistle (seedling), kochia, and certain other weeds in established alfalfa grown for seed.

Do not apply within 30 days of harvest (cutting for hay), or feeding of forage, or grazing.

APPLICATION INFORMATION

Dormant Varieties

Make a single application after alfalfa becomes dormant and before new growth exceeds 2 inches in height in the spring.

Where weeds have emerged, use a surfactant.

USE RATES

1 1/3 to 2 pounds per acre

Kochia	<i>Kochia scoparia</i>
Lettuce, prickly*	<i>Lactuca serriola</i>
Quackgrass*	<i>Elytrigia repens</i>
Thistle, Canada (seedling)	<i>Cirsium arvense</i>

*Suppression

Refer to the VELPAR® DF EPA registered-label for specific use rates. Select the appropriate rate based on the soil texture and percent organic matter content of the alfalfa fields to be treated. Use higher rates on hard-to-control weed species, fine textured soils, soils containing greater than 5% organic matter, or under adverse environmental conditions such as temperature extremes or when weeds are stressed due to low rainfall.

RESTRICTIONS

Do not exceed 2 pounds DuPont™ VELPAR® DF herbicide per acre per application.

Do not exceed 2 pounds (1.5 pounds active ingredient hexazinone) per acre per year.

For use under this SLN label, do not apply this product through any type of irrigation system.

REPLANTING (FOLLOWING ALFALFA)

- Do not replant treated areas to any crop except corn, root crops or sugarcane within two years after treatment, as crop injury may result.
- Corn may be planted 12 months after the last treatment in areas of moderate to high rainfall (greater than 20 inches), provided the use rate did not exceed 1 pound per acre.
- Root crops such as potatoes, sugarbeets, radish and carrots may be planted 12 months after last treatment, provided the use rate does not exceed 2/3 pound per acre. Sites with use rates higher than 2/3 pound per acre should not be replanted to any root crop within 2 years after application of DuPont™ VELPAR® DF, or unacceptable crop injury may result.
- In areas where irrigation is needed to produce the crop, the crop rotation intervals listed may need to be extended if the normal irrigation amount is reduced for any reason.

USE PRECAUTIONS

Do not use VELPAR® DF on fields with sandy loam or loamy sand soils having less than 1% organic matter.

Do not exceed 2/3 pound per acre on fields with sandy loam or loamy sand soils having 1 to 2% organic matter.

Do not exceed 2/3 pound per acre on seed alfalfa that has been established for only one growing season.

Injury may occur when applications of VELPAR® DF are made to alfalfa planted in fields having a shallow hardpan layer.

Do not use VELPAR® DF on gravelly or rocky soils, exposed sub-soils, hardpan, sand, poorly drained soil, or alkali soils.

Crop injury, including mortality, may result in fields with restricted root growth due to non-uniform soil profiles such as gravel bases and clay lenses.

Do not stress the alfalfa as crop injury may occur. Conditions that might cause injury could include drought stress followed by irrigation resulting in a rapid uptake of product into the plant.

If abnormally dry conditions exist following application, restrict the first irrigation to no more than 1/2 inch of water.

CONTAINER DISPOSAL

Plastic containers - WSDA Container Disposal Guidance:

Pesticide containers must be properly cleaned prior to disposal. The best time to clean empty pesticide containers is during mixing and loading, because residue can be difficult to remove after it dries. Triple rinse (or pressure rinse) the pesticide container, empty all pesticide rinse water into the spray tank, and apply to a labeled crop or site. Recycling cleaned containers is the best method of container disposal. Information regarding the recycling of empty and cleaned plastic pesticide containers in Washington is available on the internet from WSU at <http://pep.wsu.edu/waste/wd.html> or from WSDA at <http://agr.wa.gov/PestFert/Pesticides/WastePesticide.htm>. Cleaned containers may also be disposed of in a sanitary landfill, if permitted by the county. Burning is not a legal method of container disposal in Washington.
